


Submission:1

General Comment

- 1. The New Zealand Recreation (NZRA) is a registered charity and the organisation responsible for providing leadership, advocacy and professional development opportunities for those involved in the broader recreation sector. Its role is to champion high quality recreation for the benefit of New Zealand.
- 2. The New Zealand Recreation Association's membership includes recreation policy makers, territorial local authorities, voluntary organisations, regional sports trusts, outdoor recreation businesses, and others involved in the delivery of recreation in New Zealand.
- 3. Tramping is the 9th most popular form of Active Recreation for New Zealanders, with 9.7% of the population participating in that activity at least once every 12 months. Cycling (which includes both mountain biking and cycling) is the 3rd most popular form, with 24.8% of the population participating. [Sport New Zealand – Active New Zealand Survey 2013/14].
- 4. NZRA is supportive, in principle, of the establishment and maintenance of walking and cycling tracks by the Department of Conservation. NZRA notes that the Department is responsible for the management of 1/3rd of New Zealand's Land Mass, that it spends approximately \$150m in the provision of recreation infrastructure per annum and that nearly half of all New Zealanders visit Public Conservation Land for recreation the purpose at least once a year.
- 5. With regard to the Turoa to Ohakune proposal specifically, NZRA is supportive, but has concerns about the following matters:
- A) the standard to which the track will be constructed and maintained.
- B) The extent to which the track could be reasonably shared and enjoyed by walkers and Mountain bikers, concurrently.
- C) How conflict between user groups would be reported, measured and acted upon.
- D) How breaches of the mountain biking code of conduct would be investigated and sanctioned.
- 7. With regard to the Mountain Road through to Horopito proposal, specifically, NZRA is supportive.
- 8. With regard to the Horopito to National Park (the Missing Link) proposal, specifically, NZRA is supportive and commends both the Ruapehu District Council and the Department on their spirit of mutual cooperation.
- 9. In general, NZRA encourages the Department to implement data capture systems that clearly differentiate between mountain bikers and trampers, in order to make more inform management decisions in the future.
- 10. NZRA is supportive of the departments guideline on Electric bikes on public conservation land. NZRA supports and would insist upon the definition of an e-bike as those having less than 300 watts of power and being pedal assisted.

4.1	Support	NZRA commends the extent to which the Department has been open and accommodating to community-led initiatives. NZRA submits that generally, there is much greater scope for cooperation and mutual benefit between DoC and Local Territorial Authorities to improve the provision of recreational opportunities.
4.4 (Social)	Support with amendment	NZRA submits that there needs to be a greater degree of monitoring, compliance and enforcement with regard to sharing walking track with mountain bikers. More recent research is required. There could be a great deal of unreported conflict. It could be the case that walkers avoid mixed-use tracks at all, thus avoiding conflict.
4.4 (Electric power-assisted cycles (e-bikes))	Support with amendment	NZRA submits that a greater degree of monitoring, research and study needs to be undertaken in this area. Especially with regard to the potential degradation of tracks and conflict between user groups. NZRA supports the departments definition of e-bikes as those having less than 300 watts and being pedal assisted.
4.5	Support	NZRA would remind the department of its legal obligation to foster recreation on Public Conservation Land and that this obligation takes greater precedence than its obligation to allow for tourism.
